

**United Way of Lake County 2016 Toyota Corolla Car Raffle  
Official Contest Rules**

1. PURCHASE NECESSARY. To win, one must purchase a raffle ticket and have it entered into the drawing. Odds of winning are based on the number of entries received. Drawing to be held on March 17, 2016 between 11:30 am – 1:30 pm at LaMalfa, located at 5783 Heisley Rd, Mentor, OH 44060. Tickets will be entered into a drawing and winner does NOT need to be present to win. Winner will be notified the day of drawing or on the date following this.
2. Participation in the Contest constitutes entrant's full and unconditional agreement to and acceptance of these Official Contest Rules.
3. One (1) Prize Winner will receive his/her 24 month lease of a new 2016 Toyota Corolla S Plus with Moon Roof from Classic Toyota Scion, Inc. Lease includes 12,000 miles per year. There is no cash alternative in lieu of the vehicle lease. The approximate retail value of the prize is \$5,000. Should this prize be unavailable at the time of awarding, Classic Toyota Scion, Inc. reserves the right to substitute another prize of equal or greater value.
