

## **United Way of Lake County 2018 Donor Appreciation Giveaway**

### **-Official Contest Rules-**

1. **HOW THE CONTEST WORKS:** The number of contest entries you receive depends upon the dollar amount you pledge/give to United Way of Lake County each week for one year (52 weeks). Get one (1) contest entry for every dollar you donate per week for a year. For example, by pledging/giving one dollar per week (\$52/year) you will get one contest entry, by pledging/giving two dollars per week (\$104/year) you will get two contest entries, by pledging/giving three dollars per week (\$156/year) you will get three contest entries, and so on. Your United Way of Lake County donation/pledge is your entry into the contest.
2. Your United Way of Lake County (UWLC) donation is your entry into the contest. Odds of winning are based on the number of entries received. Donors must be 18 years or older at time donation is made to qualify for entry into the contest.
3. Donations must be made to United Way of Lake County (UWLC), which is located in Mentor, Ohio. Donations made to other United Way's do not count for purposes of this contest.
4. If you make a donation through your UWLC workplace campaign, the paper or electronic pledge form you filled out will serve as your entry into the contest. If you make a donation online at [www.uwlc.org](http://www.uwlc.org), the contribution form we receive when you click the "Make Contribution" button to submit your donation will serve as your entry into the contest.
5. The names of all qualified workplace donors must be provided to UWLC by employers on a timely basis to be included in the drawing. United Way of Lake County shall not be held accountable for any failure to submit entries. Donors who give online at [www.uwlc.org](http://www.uwlc.org) are automatically entered into the contest.
6. Contest ends February 1, 2019. Ten (10) finalists will be drawn on or about February 22, 2019 and will be invited to attend a grand finale event which will take place on or about March 1, 2019. During the March 1, 2019 grand finale event, finalists will each have an opportunity to select a key. The person with the key that starts the car wins and gets to choose between a 2-year lease on a new 2019 Chevy Cruze LS with all taxes & fees included or \$5,000 cash. All finalists will be notified by phone and/or email on or around the date of the February 22, 2019 drawing.
