## **United Way of Lake County HeroFest Raffle**

-Official 2023 Contest Rules-

- 1. You may purchase as many entries for each raffle prize as you like. Entry rates are listed next to each raffle prize.
- 2. You must be 18 years or older to participate in the raffle. However, you must be 21 years of age or older to purchase entries for any of the prizes where liquor or alcohol are provided as part of the prize raffle basket.
- 3. Odds of winning are based on the number of entries each raffle prize receives.
- 4. Raffle begins Tuesday, August 1, 2023 at 12:00 am and ends Sunday, August 20, 2023 at 3 pm. Selection of the winners are automated and will be held shortly following the raffle end time on August 20, 2023. There is one exception to this, which is outlined below (see contest rule #5).
- 5. The winner of the 2023 Nissan Sentra SV or \$15,000 prize contest started May 25, 2023 and ends August 20, 2023. Selection of this winner will occur as follows: Ten (10) finalists will be selected on or about August 25, 2023 and invited to attend our campaign kickoff celebration on August 30, 2023, where the winner will be determined by whose key starts the ignition; Finalists need not be present to win and may choose to either send someone to represent them or opt for us to choose someone on their behalf.
