-Official 2022 Contest Rules-

1. HOW THE RAFFLE CONTEST WORKS:

There are 3 weekly contest raffles, each offering a different selection of raffle prizes. You may participate in as many contest raffles as you like and may buy as many entries for each prize as you like. Entry rates are listed next to each raffle basket prize.

4. Raffle Contest Dates:

Raffle #1 Contest: This raffle begins Tuesday, May 3, 2022 at 12:05 am and ends Monday, May 9, 2022 at 11:59 pm. Selection of the winners are automated and will be held and announced on or about Tuesday, May 10, 2022.

Raffle #2 Contest: This raffle begins Tuesday, May 10, 2022 at 12:05 am and ends Monday, May 16, 2022 at 11:59 pm. Selection of the winners are automated and will be held and announced on or about Tuesday, May 17, 2022.

Raffle #3 Contest: This raffle begins Tuesday, May 17, 2022 at 12:05 am and ends Wednesday, May 25, 2022 at 11:59 pm. Selection of the winners are automated and will be held and announced on or about Thursday, May 26, 2022.

- 5. Winners will be notified by phone or email and arrangements will be made for winners to pick-up prizes from a location in Mentor, Ohio. We are unable to ship raffle prizes. Winners may be asked to present a valid Photo I.D. before the winning gift is provided. Winners of any prizes containing alcohol or liquor must provide a valid Photo I.D. before the winning gift is provided.
- 6. There will be three 50/50 raffles. One will be held during each of the three above listed weekly contests. One winner will be selected for each raffle. The winners of each 50/50 raffle will receive a dollar amount equal to half of the total raffle ticket entries purchased from the time period each individual raffle was held.
