- 4. Drawing to be held on or about January 26, 2018. Ten (10) finalists will be drawn to attend a UWLC event on or about February 2, 2018 where they will each have an opportunity to select a key. The person with the key that starts the car wins and gets to choose between a 2-year lease on a 2018 Toyota Corolla LE with all taxes & fees included or \$5,000 cash. Finalists will be notified by phone and/or email. Finalists will be notified on or about the date of the drawing.
