The United Way of Lake County Emerging Leaders' "4 Under 40" awards seek to recognize Lake County's best and brightest young professionals in the areas of leadership, community involvement, entrepreneurship and professional accomplishment. The eligibility to receive a "4 Under 40" award are as follows:

- Nominee must be between the ages of 21-40 during the year ending December 31, 2020.
- Nominee must live or work in Lake County.

The Young Professional should demonstrate success in at least one of the following areas:

- **Leadership:** Nominee should show that he/she can take charge and motivate others within his/her organization or in the community.
- **Community Involvement:** Nominee should provide valuable service by contributing time and energy in service to the community, including but not limited to serving on local boards and/or committees or by volunteering at community events.
- **Entrepreneurship:** Nominee should demonstrate the ability to utilize his/her available resources, knowledge and business relationships to build an organization and create value in Lake County.
- **Professional Accomplishment:** Nominee should demonstrate excellence and show initiative in their company or profession.

After nominations close on November 25, nominees will be notified and asked to complete a short questionnaire. The additional information provided by the nominee will be included along with this nomination form for the Selection Committee to review.

Nominations will be reviewed and winners will be determined by a Selection Committee comprised of local professionals from a variety of business sectors and nonprofit organizations.
